## XII International Salon of Photography. Digital.

In the town of Reus, Catalonia, from 1973 to 1993, the International Biennial of Photography Europa was organised. It was twenty years and eleven biennials, all curated by Mr. Enric Pàmies, HonEFIAP, honorary president FIAP. The Salon Europa alternated with FOTOSPORT, also in Reus, which since 1970 has been held continuously until present.

We would like to restore this event with a completely updated format, however maintaining the same spirit. From the town of Reus we would also like to project ourselves to Europa and the world. We would like to receive the best pictures from around the world that artists would like to send us.

## HOW TO ENTRY:

1. Images, digital only, **must be** uploaded via website to:  
[www.fotosportreus.cat/europa/](http://www.fotosportreus.cat/europa/)
2. Entry form **must be** submitted electronically via website, following the instructions on screen.
3. Images must be in JPG format. Maximum dimensions: 1024 pixels horizontal and 768 pixels vertical. Resolution 300 ppi. Maximum size of a file is 1 MB.
4. Entry fee:
  - One section: 15€ or 22 USD
  - Two sections: 20€ or 30 USD
  - Three sections: 25€ or 37 USD
  - Four sections: 30€ or 44 USD

Payment entry fee only by PayPal via website [www.fotosportreus.cat/europa/](http://www.fotosportreus.cat/europa/) when fill entry form and uploaded photos.

5. Entries not complying conditions of entry and/or without full payment of entry fee will be disqualified.

## CONDITIONS OF ENTRY:

1. **EUROPA 2012** Salon is open to all photographers worldwide, except members of the organisation and/or jury. However, an entry may be rejected when organisation, in its reasonable discretion, believes the entry does not conform to the salon rules and conditions.
2. Acceptances at **EUROPA 2012** will be taken into account for FIAP, ISF, CEF and FCF.
3. A maximum of four images may be entered per section. The same image must not be entered in more than one section.
4. All entrants will receive a high quality CD catalogue.
5. The act of participating means that the authors consent to their works being copied for the purpose of disseminating **EUROPA 2012** Salon and photography in general, without any limitations as regards the system, means or countries involved without paying any royalties. All entrants are responsible for the rights of any third parties and for any claims arising due image rights.
6. Decisions of the jury are final.
7. Participation in **EUROPA 2012** entails complying in full with these rules.
8. Any contingency will be resolved by the organization.
